

THE ROMANIAN SENATE MAY PUT CHILDREN IN DANGER

Today, November 2, the STOP-AT project consortium members were informed that 88 members of the Romanian Senate are promoting a bill that endangers minors and those with rights assimilated to them.

The Draft Law "B658/2022 Legislative proposal to amend and supplement Law no. 248/2005 on the regime of free movement of Romanian citizens abroad, as well as to amend article 23 of Law no. 272/2004 on the protection and promotion of children's rights" aims changing the legal regime of circulation abroad for minors, reducing the age from 18 to 16. This legislation was introduced in the Senate on October 24th and appears to be moving quickly through the legislative process.

The change comes in the context where Ukrainian children have the right to travel unaccompanied from the age of 16. The reduction of the age of movement abroad for minors, from 18 to 16, makes Romanian and Ukrainian children even more vulnerable to organized crime networks that are very active in both countries. In practice, the removal from Romania of children, potential victims of trafficking in minors or other forms of crime, will be facilitated by this legislative amendment.

We underline that Romania has the largest number of trafficked minors in Europe and that their number has increased 10 times in 2 years, according to the European Commission's Report "Data collection on trafficking in human beings in the EU", page 33, published in October 2020.

Statistical data for 2020, published by the <u>Government of Romania</u> and processed by <u>ECLER</u>, shows that the number of exploited children is constantly increasing, covering all ages - from 1 year to 18 years, with a very high percentage of children between the ages of 16 and 18 who are especially <u>sexually exploited</u>.

The STOP-AT project consortium members ask the Romanian Senate to urgently withdraw Bill B658/2022, which, which, in the specific context of our country and related to the data

presented above, cannot be an effective legislative amendment and in favour of the Romanian children or of those located on the territory of Romania.
